Adv. Disha Wadekar

Supreme Court of India

Adv. Disha Wadekar is an advocate practicing in the Supreme Court of India. She has worked as an associate at the chambers of Sr. Adv. Indira Jaising on constitutional matters including the Sabarimala case and the Jarnail Singh case (reservation in promotions). Advocate Wadekar has also headed a legal resource center set up under a project by London School of Economics. Her work has involved representation in cases of campus discrimination, atrocities against Scheduled Castes/Scheduled Tribes and custodial torture. Wadekar Ma'am has also represented victims of violence at Bhima Koregaon in 2018. She has previously worked as a Consultant Advocate for Project 39A at National Law University, Delhi, and Centre for Women's Development Studies, New Delhi.



Adv. Flavia Agnes

Co-founder, MAJLIS

Adv. Flavia Agnes is our Hon'ble speaker for the second day. She is a legal scholar and women's rights lawyer who has been able to combine her legal scholarship with active litigation support to victims of domestic and sexual violence. Adv. Flavia Agnes started working in the field of women in law in the 1980s, at the start of the second phase of the women's movement, and has been a practicing lawyer at the Mumbai High Court since 1988. Her personal experience with domestic abuse led her to pursue a career as a lawyer for women's rights. She also advises the government on the execution of laws, and she is now advising Maharashtra's Ministry of Women and Child Development.

She is a co-founder of MAJLIS, which stands for "association" in Arabic and refers to a "legal and cultural resource centre" that advocates for and represents women on topics such as marital rights, child custody, and other legal matters. MAJLIS has offered legal assistance to 50,000 women, many of whom are impoverished, and counseled three times as many since its founding in 1990. She has authored and published several essays in publications such as Subaltern Studies, Economic and Political Weekly, and Manushi. Significant among her many publication is her autobiographical book My Story Our Story...Of Rebuilding Broken Lives, translated into several languages and its fourth edition.
